Bridal Trials & Consultations

- Bridal trials and consultations are carried out in my cosy home studio in Fairlie.
- I can accommodate up to 2 guests should you wish to bring someone along for support.
- If you are unable to attend a trial at my home studio, we can discuss other trial arrangements.
- Payment for the trial is due at the time of the trial by cash or bank transfer.

Booking & Deposit

- A non-refundable deposit of 30% of the price quoted per person is required.
- Your booking is only confirmed once payment of the non-refundable deposit has been received.
- Until the deposit is received, the date remains open to other enquiries.

Travel Costs

- Travel is charged at £0.55 per mile from my location in KA29 ODZ, unless your venue is within a 10-mile round trip.
- Mileage is calculated as a round trip.
- Any extra charges like parking, tolls, or congestion fees will also be added to your final invoice.



Early Starts & Overnight Stays

- If the location requires more than 2 hours of one-way travel from my base, and services are scheduled to begin before 8:00 AM, then I kindly ask that overnight accommodation be arranged by you.
- This helps ensure I arrive fresh, on time, and fully prepared to give you and your bridal party the best possible service without the risk of early morning travel delays.
- We can go over all the specifics during your trial session, including travel time and accommodation details, to make sure everything is agreed in advance and works well for both of us.

Changes to Your Booking

- Final numbers for makeup services must be confirmed no later than 4 weeks before your wedding.
- If party numbers decrease after this time, the original agreed cost will still apply.
- Want to add someone? I'll do my best to accommodate, but it will depend on timing and availability — and there may be an additional charge.



Cancellations

- The deposit is non-refundable in all cases.
- · If you need to cancel:
 - More than 12 weeks before the big day: only the deposit is kept.
 - Between 12 and 4 weeks before: 50% of the remaining balance is due.
 - Less than 4 weeks before: the full balance is due.
- If I (Lizzie) can't attend due to illness, emergency, or circumstances beyond my control, I'll do everything I can to find a trusted replacement. If no one is available, you'll receive a full refund, including your deposit.



Photos & Social Media

- I sometimes take a few photos or short videos of my work for use on social media, my website, or promotional materials — always respectfully and discreetly.
- If you or any of your party would prefer not to be photographed or featured, just let me know in writing when you book. Absolutely no problem!

What I Need from You

- Please make sure everyone having makeup done is on time and has clean, makeup-free skin when I arrive.
- Any allergies, sensitivities, or medical conditions must be shared in advance so I can plan accordingly.
- To ensure you get the very best results, I kindly ask that a room with plenty of natural light is made available for makeup on the day of the wedding (when possible).
- Please also provide a clean, flat surface or table where I can safely set up my makeup kit, along with a nearby power socket if possible.
- A comfortable chair at standard height (not too low or high) is also really helpful to keep things running smoothly.



Liability

- I always do my best to work safely and professionally, but I can't be held responsible for any allergic reactions, injuries, or issues if I haven't been told about allergies or sensitivities beforehand.
- I am fully insured to provide makeup services through Salon Gold and take every precaution to maintain a safe, clean, and professional environment at all times.

During Makeup Application

- For the comfort and hygiene of everyone involved, I kindly ask that no smoking or vaping takes place while makeup is being applied — either by the client or anyone nearby.
- This helps maintain a clean environment, protects the products and brushes, and ensures your makeup stays flawless during application.



Payments
